# B) Caller Issues

- > Payments for Travel Expenses
  - > Peter suggested a procedure be established where the board members approve stipends for gas on a per caller basis.

It was pointed out that we are having difficulty filling fly-in committee positions.

### D) Summer Dance location

Michelle will call and get a price to rent the Wealthy Street Theater again, she will compare that to last years rent and report back.

- E) GR Pride Weekend (June 15th)
  - > The event has moved to the Calder Plaza this year
  - > We are looking to partner with the Renegades again to share the expenses of the floor and booth, and to share the sound system. The renegades are looking into the possibility of getting a bigger booth and larger dance floor. The board voiced concerns as to the need for these additions and requested pricing before making that decision.
  - > Kim Kennedy will contact Ken Burke to book as our caller for the event
  - > We need to address supplying water for the event
  - > Peter will get with Jerry and Don from the Renegades for more details.
- F) Lansing Pride Weekend (August 24th)
  - > We discussed the possibility going to the Lansing Pride weekend and setting up a booth. This was tabled to be discussed at a later date.
